Tuesday, June 18, 2024, 7:00 P.M. **Town Board Meeting**

1. CALL TO ORDER, ROLL CALL, PLEDGE OF ALLEGIANCE Chairman Laufenberg called the meeting to order at 7:00 p.m.

Motion by Chairman Laufenberg, seconded by Sup. Wright to form the ATV/UTV committee as proposed with the specified appointments. Motion carried, 5-0.

8. HOLDING TANK REQUEST FOR ADVANCED CONCRETE, LOT 3 DARLIN DR.

Motion by Sup. Dresen, seconded by Sup. Zinck to grant Advanced Concrete a holding tank permit. Motion carried, 5-0.

9. ELECT DANE COUNTY TOWNS ASSOCIATION DISTRICT 6 REPRESENTATIVE

Motion by Sup. Meinholz, seconded by Chairman Laufenberg to approve the nomination of Greg Hyer to be the Dane County Towns Association District 6 representative. Motion carried, 5-0.

10. ROAD PROJECT FINANCING

The board would like this added to a future agenda this fall when they will discuss 2025 projects and bid requests.

11. 2024 ROAD PROJECTS

Patrolman Ripp will get wedging price for a portion of Woodland Drive for a band-aid option.

The clerk will see what other municipalities utilize the court for and what they do for code enforcement.

14. OLD BUSINESS

a. BLIGHT, 7166 COUNTY HWY. K

Chairman Laufenberg, and Supervisors Dresen and Wright conducted a site visit before the meeting; the site was cleared of the majority of rubbish and rotten food stuffs, but still needs to have the weeds eradicated, the lawn mowed, the dead tree taken down (it's hanging over a power line), and a couch removed from the front yard. Mr. Wagner will have the tree removed himself or have an accepted contract for the tree removal to the Town by the July 2nd town board meeting.

Motion by Sup. Zinck, seconded by Sup. Wright to have the Town have the property mowed and weeds sprayed at property owner's expense and continue oversite. The furniture must be removed by Thursday or the Town will contract someone to have it done. Motion carried, 5-0.

b. IGA RENEWAL DISCUSSIONS WITH CITY & VILLAGE

Motion by Sup. Wright, seconded by Sup. Meinholz to prepare a letter signed by the Board to the Village Council informing them the Town has decided to move forward with full adoption of the existing IGA with either a new 10-year expiration date or the original expiration date, and intends to schedule a public hearing for it within two months. Motion carried, 5-0.

c. PARK IMPROVEMENTS

New equipment will be cost prohibitive; supervisors will reach out to contacts for used equipment.

5d. DESIGN REVIEW – LOT 11 DARLIN DRIVE, PARCEL 0808-092-0688-0 MEINHOLZ EXCAVATING

PC ACTION: MOTION BY COMMISSIONER WRIGHT, SECONDED BY COMMISSIONER BALLWEG TO APPROVE THE DESIGN REVIEW OF LOT 11, DARLIN DRIVE PENDING AN APPROVED LANDSCAPE PLAN AND APPROVAL OF COLOR. MOTION CARRIED, 5-0.

Motion by Sup. Zinck, seconded by Sup. Wright to approve the Design Review for Meinholz Excavating, Lot 11 Darlin Drive, pending approval of the landscape and lighting plans, and resolution of stormwater issues. Motion carried, 5-0.

<u>Supervisor III:</u> Waunakee EMS is going well. One ambulance is temporarily out of service so the District is borrowing one. Sup. Meinholz would like the board to review the Landscape Plan requirements and enforcement of the Design Review ordinance; staff will add to a future agenda.

<u>Supervisor II</u>: Waunakee Fire didn't meet in May; they'll meet later in June.
