MEETING MINUTES

Tuesday, July 2, 2024, 7:00 P.M. Town Board Meeting

1. CALL TO ORDER, ROLL CALL, PLEDGE OF ALLEGIANCE Chairman Laufenberg called the meeting to order at 7:00 p.m.

Roll call shows Chairperson Dave Laufenberg and Supervisors Dan Dresen and Art Meinholz present. Supervisors Matt Wright and Leon Zinck III were absent.

Also present were Clerk-Treasurer Dianah Fayas, Deputy Clerk-Treasurer Doreen Jackson, Road Patrolman Darin Ripp, Waunakee Area EMS Chief Scott Russell, Cross Plains EMS Chief Holly Ellickson, City of Middleton EMS Chief Steven Wunsch, Dan Ziegler, Vern Acker, John Acker, and Howard Wagner.

Pledge of Allegiance was recited.

- 4. MINUTES OF PREVIOUS MEETING: June 18, 2024

 Motion by Sup. Dresen, seconded by Sup. Meinholz to approve the minutes. Motion carried, 3-0.
- 5. EMS RESPONSE TIMES

The City of Middleton, Waunakee Area, and Cross Plains EMS Chiefs reviewed the response time information with the Board and will put together a proposal for modifications in the district boundaries as needed to best serve the residents of Springfield and send it to the Town Clerk to provide to the board.

6. DRIVEWAY APPLICATIONS: DAN & DALLAS ZIEGLER, CHURCH RD. AND LAUFENBERG BROS., 6973 RILES RD. Motion by Sup. Meinholz, seconded by Sup. Dresen to approve the driveway permit for Dan and Dallas Ziegler on Church Road. Motion carried, 3-0.

Motion by Sup. Meinholz, seconded by Sup. Dresen to table the Laufenberg Bros. application until the next meeting. Motion carried, 3-0.

- 7. OPERATOR'S LICENSE: LISA STATZ AND ERIKA KALSCHEUER, CONNIE'S

 Motion by Sup. Dresen, seconded by Sup. Meinholz to grant the operator's license for Lisa Statz and Erika Kalscheur at Connie's. Motion carried, 3-0.
- 8. RECOMMENDATIONS OF THE PC 6/10/24:

a. JOHN ACKER, CSM & REZONE FROM AG TO SFR FOR TWO NEW RESIDENTIAL LOTS, PARCEL 0808-091-9960-0, LODI-SPRINGFIELD RD.

PC ACTION: MOTION BY COMMISSIONER WRIGHT, SECONDED BY COMMISSIONER WOLFE TO APPROVE THE CSM AND REZONE TO SINGLE FAMILY RESIDENTIAL (SFR) FOR PARCEL NUMBER 0808-091-9960-0, WITH A RIGHT TO FARM NOTICE ADDED, AN APPROVED SHARED DRIVEWAY AGREEMENT AND THE CSM RECORDED WITHIN 120 DAYS. MOTION CARRIED, 5-0.

This CSM utilizes two development rights from Farm #9.3, leaving one split remaining for Farm 9.3. The shared driveway agreement must address the possibility of future homes and shared access in Lot 3.

Motion by Sup. Meinholz, seconded by Sup. Dresen to approve the CSM and rezone from Agricultural (AG) to Single Family Residential (SFR) for two lots, incorporating the Plan Commission's action language specifically an approved, shared driveway agreement. Motion carried, 3-0.

The indoor furniture has been removed from the front yard, the dead tree has been taken down, the lawn was mowed and the weeds were sprayed. This item will be removed from the agenda with a reminder to the property owner to stay on top of the situation and not bring in food stuffs not intended for human consumption in the near future.

The old truck will be posted for sale once Patrolman Ripp no longer needs it for brooming. Patrolman Ripp reported on the annual digester meeting and updated the board on the 2024 road projects and the high estimate for additional paving.

The Clerk provided copies of email complaints received about Hellenbrand Road from Village residents, noted attendance at various committee meetings, report that the August absentee ballots had been mailed out, and a number of reports were submitted to the State for the July 1st deadline.
