MEETING MINUTES

Tuesday, September 17, 2024, 7:00 P.M. Town Board Meeting

1. CALL TO ORDER, ROLL CALL, PLEDGE OF ALLEGIANCE Chairman Laufenberg called the meeting to order at 7:00 p.m.

Roll call shows Chairperson Dave Laufenberg and Supervisors Dan Dresen, Matt Wright, Art Meinholz, and Leon Zinck III present.

Also present were Clerk-Treasurer Dianah Fayas, Deputy Clerk-Treasurer Doreen Jackson, Attorney Hazelbaker, Andy and Lisa Bindl, Becky and Kelly Lindeman, Drew Lawrence and Kevin Heppner. Mark Roffers and Jeff Endres arrived at the end of Open Session and the beginning of Closed Session.

Pledge of Allegiance was recited.

A Waunakee resident reported that during heavy rains earlier this summer, Waunakee's Westbridge subdivision's stormwater system was insufficient to deal with the water it received from the storm and from farmland to the west which is located in Springfield.
